Background Scenario

You and your partner are on duty at a local fair. It is a beautiful summer day, hot and a slight breeze is blowing. A fair attendee walks into your first aid post and states he/she is not feeling well. Good Luck!

There will be a 3 minute warning to the judges to signify the end of the primary survey. There will also be a 2 minute left signal for the team's benefit.

(BACKGROUND – NOT TO BE SHARED WITH COMPETITORS)

A spectator from the fair, has been enjoying a day of activities, when he/she suddenly feels unwell, stumbles and falls, sustaining a 5 cm cut of palm of left hand, with moderate bleeding. The casualty walks into the first aid post, and does not realize he/she is in the beginning stages of a stroke (CVA), and will progress through the stages into unconsciousness, no matter what the team does.

INJURIES

- Initially speaks fine and answers questions appropriately, at 3 minute mark of scenario, casualty is only able to answer "Yes" to any questions that are asked after that point.
- At 10 minute mark, casualty will become unconscious and slump from chair to the ground.
- Shock (very pale, cool, clammy)
- Casualty complains of a headache and tingling left leg
- 5 cm cut on palm of left hand, with moderate bleeding.
- At 10 minute mark, judge will give casualty a signal and casualty will become unconscious for the remainder of the scenario

CASUALTY PROMPTS

- Casualty walks into first aid post, holding up left hand which is bleeding.
- Casualty was walking through the midway when they suddenly stumbled "don't know why. I cut my hand so I thought I should come to see you for a bandaid"
- Casualty has moderate amount of bleeding from palm of left hand.
- Casualty did not hit his head, but has a headache, makes him/her, feel sick to their stomach..
- Casualty is conscious until 10 minute mark, then becomes unconscious.
- Casualty is alert & fully oriented initially – answers questions accurately and obeys commands. Complains of tingling in left leg, no weakness
- Casualty becomes confused at 3 minute mark and can only answer "yes" to any questions after that point.
- Casualty has had high blood pressure for the past 10 years.
- Casualty has no allergies.
- Casualty is currently taking Lipitor, Metoprolol, and an Asprin a day.
- Casualty ate a hot dog and fries about 2 hours ago.

PROPS

- Casualty dressed in street clothes (summer), or Tyvec Overalls.
- Casualty does not wear medic alert and does not have medication with him.
- A chair in the square for casualty to sit on.

BYSTANDER'S PROMPTS

Judge will act as bystander and walk casualty into scene!

- IF ASKED. Casualty fell to the ground on the midway, you suggested he go to first aid tent..
- IF ASKED. Casualty seemed fine, but says he/she has a headache.
- IF ASKED. You can't assist with first aid, sight of blood makes you feel ill.

- Casualty has a headache 10/10 pain if asked. Tingling left leg, no weakness
- Allergies: None
- Meds: Lipitor, Metoprolol, and an Asprin a day.
- History of "high blood pressure for the past 10 years.
- Last ate a hot dog and fries, approximately 2 hours ago

At the end of the scenario, state EMS has arrived. What would you tell them in your report.
Verbal only, no paperwork allowed to be given!
