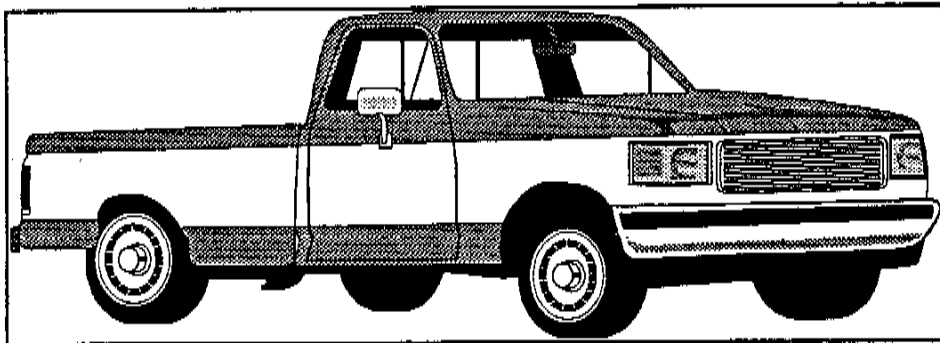

CASUALTY SYNOPSIS

CLERK -Gunshot Wound to the right chest(sucking chest wound)with matching exit wound on the back
-Left Forehead laceration with bruising on left cheek
-Broken and deformed right wrist.

Casualty Layout

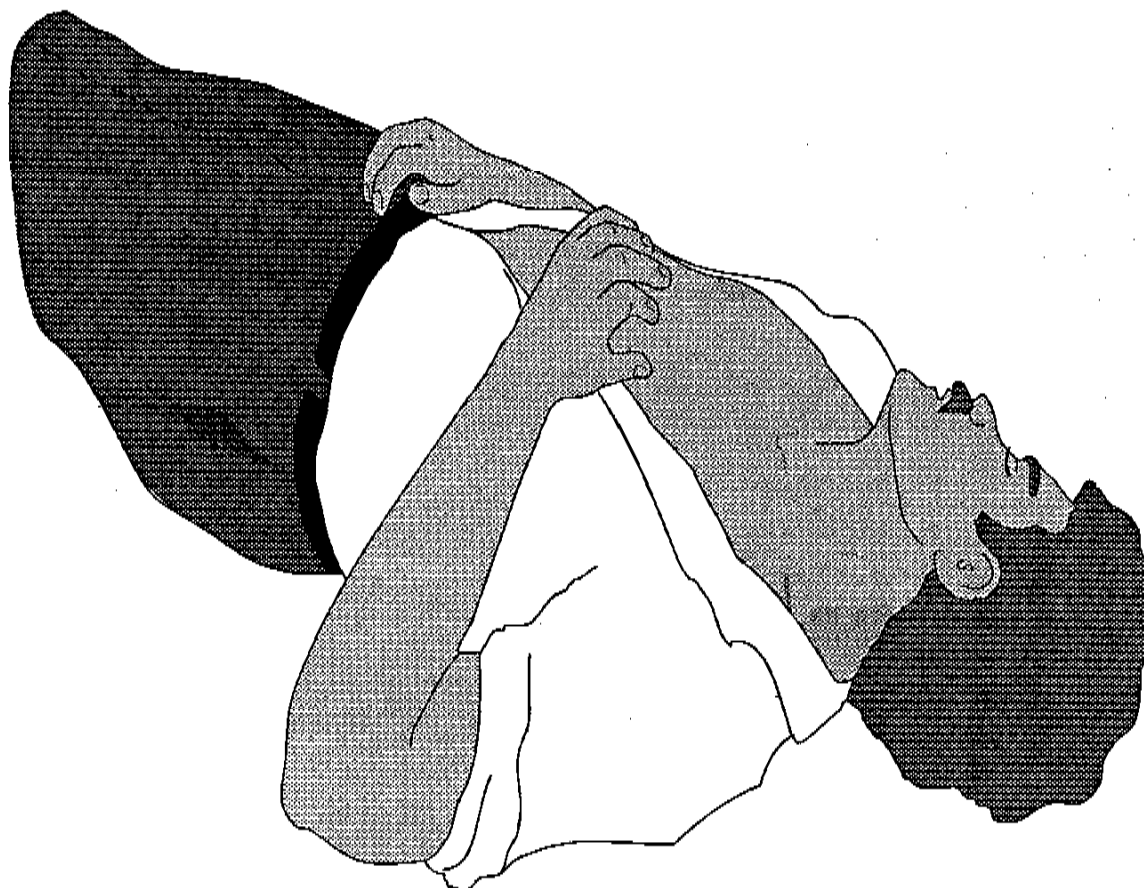
- casualty lying on back with left arm over his/her right chest

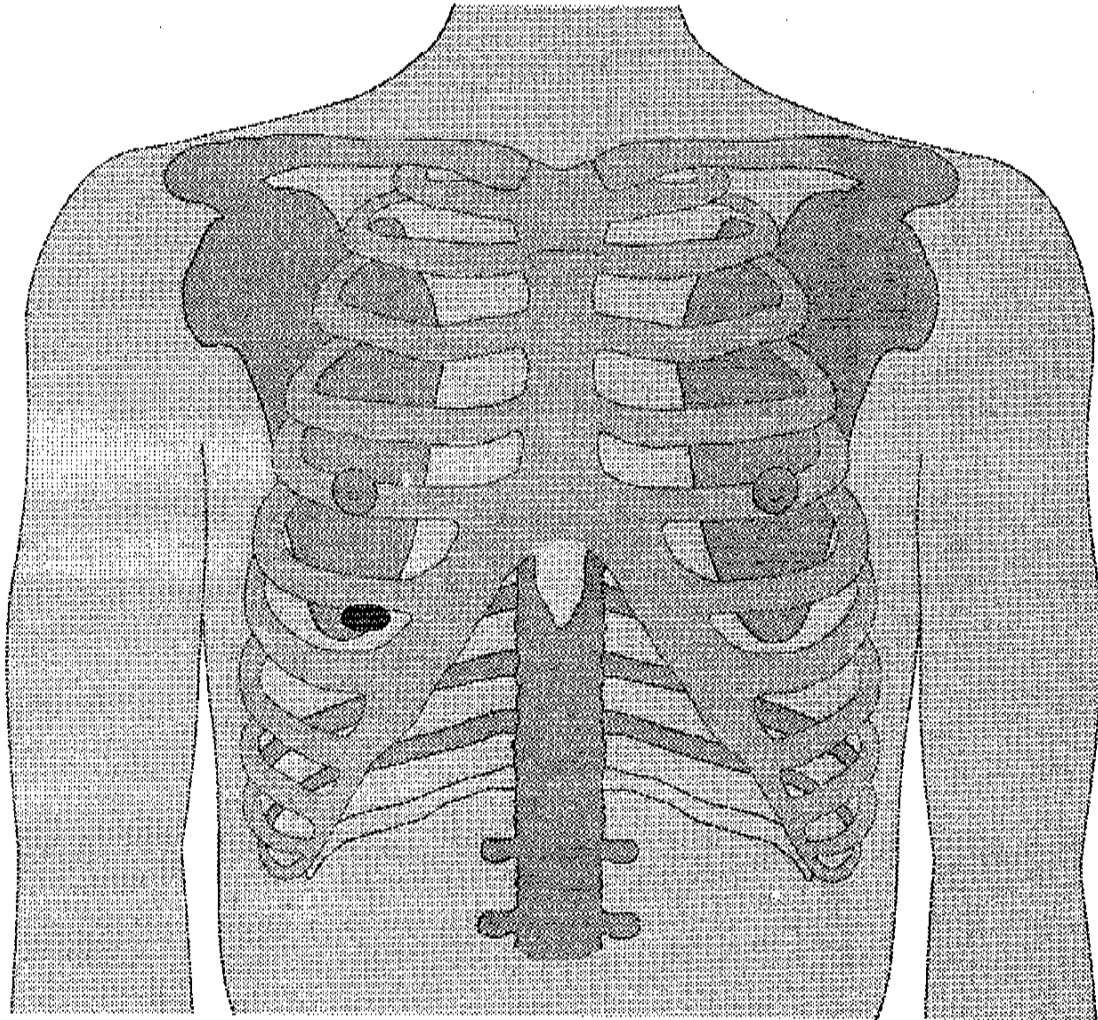
Casualty Vitals-pulse-100 weak and rapid
-respirations-32 shallow and rapid
-eyes-unequal and unreactive
-skin- pale,cool,clammy

CASUALTY SIMULATION REQUIREMENTS

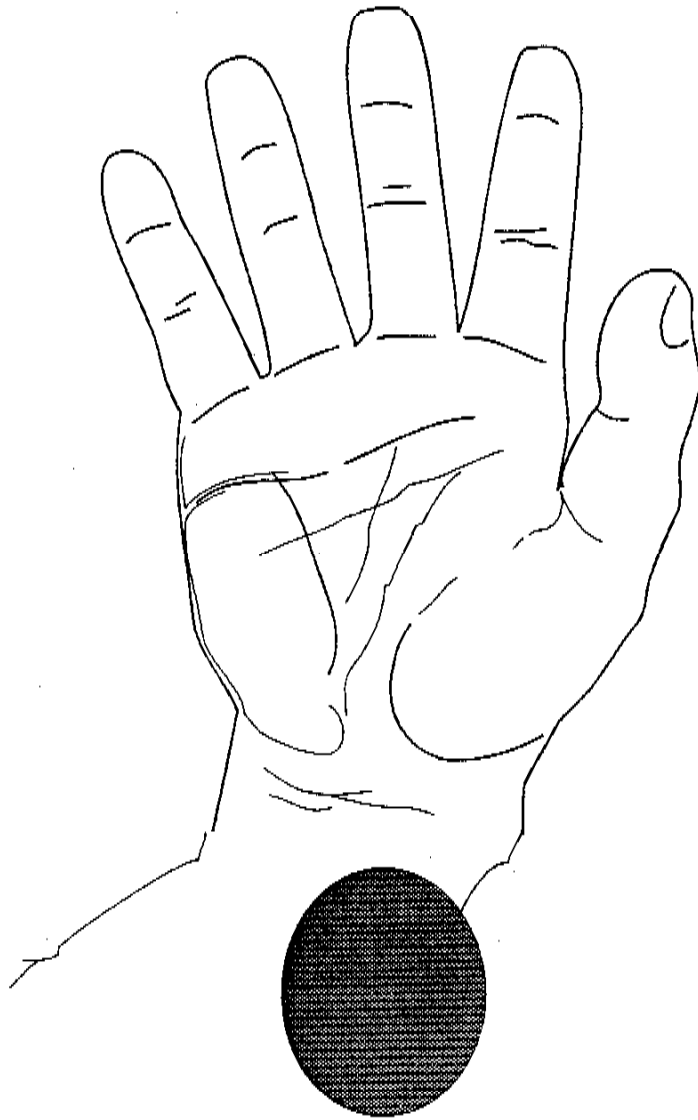
-rubber tubing for sucking chest wound

-gunshot entrance wound is a neat puncture 1/2 inch diameter(1 cm), fitted with tubing for a sucking chest wound
-2 inches (5 cm) below right nipple
-exit wound on back is a ragged one inch diameter(2 cm) crater exit wound ,lots of blood,no bubbles
-cut on left forehead just above and parallel to left eyebrow is one inch (2 cm) long, with reddening around the wound as well as reddening and slight bruising of left cheek bone
-Right wrist to be held at approx. 90 degrees with a deformity built up at the wrist joint.Some bruising
