**JUDGE'S COPY OF SCENARIO**

**TEAM SCENARIO**

It is a beautiful sunny afternoon in May in downtown Toronto. You and your partner are walking down the street. You notice many youngsters playing on their skate boards and roller blades on the concrete steps of City Hall. A young boy recognizes the St. John Ambulance uniform and rushes to you asking for help.

Good luck! The team has 15 minutes to complete the scenario.

**INJURIES**

Fractured ribs on right side with internal lung injury  
Fractured right clavicle and fractured right lower wrist  
Fracture to right cheek bone  
Suspected neck injuries  
Bruises and scratches to right and left leg

**PROPS AND EQUIPMENT**

Roller Blades should be on casualty. We should be able to simulate roller blades if unable to have real ones.  
Casualty should be wearing shorts  
Blood capsules to simulate internal bleeding from lung

**SIMULATION**

Male or Female dressed in shorts, should be a young teenager  
Should be wearing roller blades

No knee or elbow pads  
Patient is lying on side (as per video)  
Bruising to right rib area (as per video)  
Bruising to right clavicle and to lower right wrist (as per video)  
Bruising to right cheek bone  
Bruises and scratches to right and left legs (as per video)

## CASUALTY PROMPTS

Groggy and semi-conscious throughout the scenario  
Pain from right cheek area on face  
Pain from right clavicle fracture  
Pain from right wrist fracture  
Pain in area of right rib fracture  
Difficulty breathing due to rib fracture  
IF ASKED have no allergies  
IF ASKED has no medical history  
IF ASKED ate last meal about 2 hours ago  
IF ASKED what happened? Casualty should be able to state "I was roller blading and caught my wheels on the step and fell down the stairs"

READING OF THE SCENARIO IS PART OF THE 15 MINUTES.

AT THE 13 MINUTE MARK, TIME WILL BE CALLED TO INFORM TEAMS THAT THERE IS 2 MINUTES LEFT TO COMPLETE THE SCENARIO. AT THE 15 MINUTE MARK ALL WORK WILL STOP AND THE TEAMS WILL BE ALLOWED TO COMPLETE THE PATIENT CARE RECORD.
