#### CONTENT

- 1. Citizens Band Radio (C.B. Radio)
  - Procedure for obtaining a license and the regulations governing the use of CB radios.
  - Description and functions of the main parts of a CB radio.
  - Definition/use of: Base station, Telephone Handset, walkie-talkie, Mobile Station, Antenna.
  - Translation of some 10-signals Code.
  - Official radio alphabet and correct pronunciation of numbers.
  - Correct procedure for sending and receiving messages.
  - Procedures to be used in emergency situations.

# 2. Radio-telephone

The candidate must qualify for and pass the appropriate certificate issued by the appropriate Federal, Provincial or Municipal Government ministry, agency or department dealing with communications or radio licenses and examinations.

## 3. Ham Radio

The candidate must complete the requirements for the Amateur Radio Operator's Certificate as set down by the appropriate Federal, Provincial or Municipal Government ministry, agency or department dealing with communications or radio licenses and examinations.

# **DURATION**

Must complete in six months.

## **CERTIFICATION**

The candidate must satisfy the Instructor/Evaluator that they are able to make use of both skills and equipment effectively in all types of circumstances including emergencies.
